Section 6 - Health Hazard Information

Potential Health Effects

Primary Entry Routes: Skin, dermal, inhalation and ingestion.

Target Organs: Eyes, skin, respiratory system, CNS.

Effects of Overexposure: May cause irritation to the eyes, skin, nose, throat and respiratory system. Nausca, vomiting,

Section 8 - Exposure Controls / Personal Protection
